Monster is in conflict with numerous Guidelines For Selection. They are: A.1-maturity level of the pupils being served, A.2-provide materials that stimulate growth in ethical standards, A.6-select materials of high quality, A.7-each student can study issues appropriate to his or her knowledge and maturity, A.8-provide instruction free from bias,prejudice,or coercion, D.3-developmental appropriateness, D.4.c-ideologies, D.4.d-sex education, D.4.e-sex, D.4.f-profanity, D.4.h-suicide prevention, D.4.b-factual unbiased information used to portray ethnic groups or cultures.

A.1 and A.7: pg. 37 "Some guys were sexually harassing me, sir.....They wanted to have sex with me. So to save yourself from being gang raped - Is that what they wanted to do to you?" Because there are so many mature moments in the book, it, as a whole, is mature content for adults and therefore inappropriate for the maturity level of a 13 year old. A.6: For the long list of complaints with Monster I would consider it the opposite of "high quality". Mayor Giuliani The idea that we're just trying to stop crime in white or middle class areas is nonsense. Everyone living in the city deserves the same protection.", 131 "It was a registered gun. Our records show that Mr. Nesbitt applied for a license to have a gun on the premises in August of 1989. That permit was still in effect. The gun was licensed to him from that time.", 145-146, 169, 211, 244-245, 258

D.4.d and D.4.e: Numerous mentions of sexual assaults and rape. Pg. 37 "Some guys were sexually harassing me, sir.....They wanted to have sex with me. So to save yourself from being gang raped - Is that what they wanted to do to you?"

Pgs: 37, 57 "then we see him close his eyes as the sounds of the beating stop and the sounds become those of a sexual attack against the inmate who was beaten", 139, 252 (2)

D.4.h: Quite a few references to suicidal ideations which are opposite of prevention. Kids don't need tips or ideas. Pgs: 59 "They take away your shoelaces and your belt so you can't kill yourself no matter how bad it is", 144 "maybe I would think about killing myself so I wouldn't have to live that long in here", 203

D.4.b: pg. 210 and 211 "Should I take that to mean you no longer have the lamp? They don't make things to last anymore. I think it was made in Korea or some place like that". Is it factual that all products made in Korea don't last? Is it factual that all Koreans make shotty products? The author is unethically misrepresenting Koreans. Pgs: 51, 80, 81, 123, 145-146, 258 "Here is a Black woman, uneasy about her role in identifying a young Black man"
